The objectives of the Scheme is to support State Government's efforts and to make available latest agricultural technologies and good agriculture practices in different thematic areas of agriculture and allied areas to farmers through different extension activities viz. Farmers Training, Demonstrations, Exposure Visits, Kisan Mela, Mobilization of Farmers Groups and organizing Farm Schools etc.
