Is their any obligation to disburse their remuneration in PFMS from District end or it is mandatory to disburse their remuneration in PFMS under child agency i.e. FIAC account in the scheme-Support to State Extension Programme for Extension Reforms Scheme (popularly known as Agricultural Technology Management Agency)i.e. ATMA Scheme.	In so far as Directorate of Extension's ATMA Scheme is concerned, as per Department of Expenditure's O.M. dated 23 rd March, 2021, all transactions in Centrally Sponsored Scheme will be carried out through SNA account in PFMS. It is also to inform you that SNA concept has been implemented in Centrally sponsored Scheme w.e.f. 1 st July, 2021.
