While concurring to release of funds to Extension Education Institutes under Plan Scheme "Extension Support to Central Institutions on F.No.2-2/2008-ET, AS & 1'A, Department of Agriculture & Cooperation has observed as follows:-

"The practice of issuing UC: by an officer of DAC, even for grant-in-aid, is not regular, since DAC is sanctioning and releasing funds and it is for beneficiary body utilizing the funds to issue UCs. It is requested that present practice is discontinued and beneficiary body requested to submit UCs, in future."
