What are the Schemes are active and how many farmers benefitted out of it.	<b>Scheme : "Skill Training of Rural Youth (STRY) :</b> STRY was launched in 2015 with the aim to impart short term skill training to rural youths and farmers in agriculture and allied areas. The training under STRY is of 7 days duration (for 15 trainees per batch) and training activities are coordinated through State Level training institutes (SMETIs) by involving SAUs, KVKs, NGOs, Vocational Training Organisations, Youth Organisations etc.
