I am to refer to your RTI application dated 08.05.2023 seeking information on the subject cited above under the RTI Act, 2005. So far as the Directorate of Extension is concerned, the requisite information is given as under:

Information Sought	Reply
Why did not get any benefit of employee provident fund (EPF) as posted Block Technology Managers (BTMs) under ATMA, Bankura, West Bengal? Or Why BTMs are not getting EPF under ATMA, Bankura, West Bengal?	In so far as ATMA Scheme of DOE is concerned, there is a provision in the ATMA Guidelines, 2018 (vide Para:2.9(ii) that “The contractual staff will also be eligible for getting benefits of EPF, ESIC as admissible from time to time as per prevalent laws & instructions and /or options exercised by the stakeholders concerned” . However, the implementation of ATMA Scheme on the ground and service matters of manpower are in the domain of the State Government. It is advised to contact State Nodal Officer (ATMA), Government of West Bengal, 63, Jossop Building, Kolkata-700001 (West Bengal).
