According to recruitment I am next to appointed as FTA whenever seat is vacant but Supervisor Rohit Kumar donot do as per rule and donot do joining of mine. In place of me, Supervisor Rohit Kumar do joining of other person (Neelmani Singh and Viswajeet Anand) who are not given exam as well as interview by taking money. Rohit'also asked me for give money (brive) but I am unable to give money, so my joining is not done. You can also verify my eligibility through selection list. Please do strict action as soon as possible on these misconduct of Farm Tele Advisor selection process and supervisor Rohit Kumar for doing illegal management.
