1. Why ATMA functionaries not gotten their annual 10% increment for the last two years? 2. Why ATMA guideline 2018 not been implemented till now ? 3. Why they have no Health insurance coverage ? 4. Why they have no festival bonus ?	In so far as ATMA Scheme of Directorate of Extension is concerned, it is clarified that while fixing gross emoluments for contractual manpower, provisions contained in ATMA Guidelines, 2018 maybe adhered to. In any case, ceiling may not be exceeded. However, implementation of ATMA Scheme on the ground and service matters of manpower are in the domain of the State Government.
